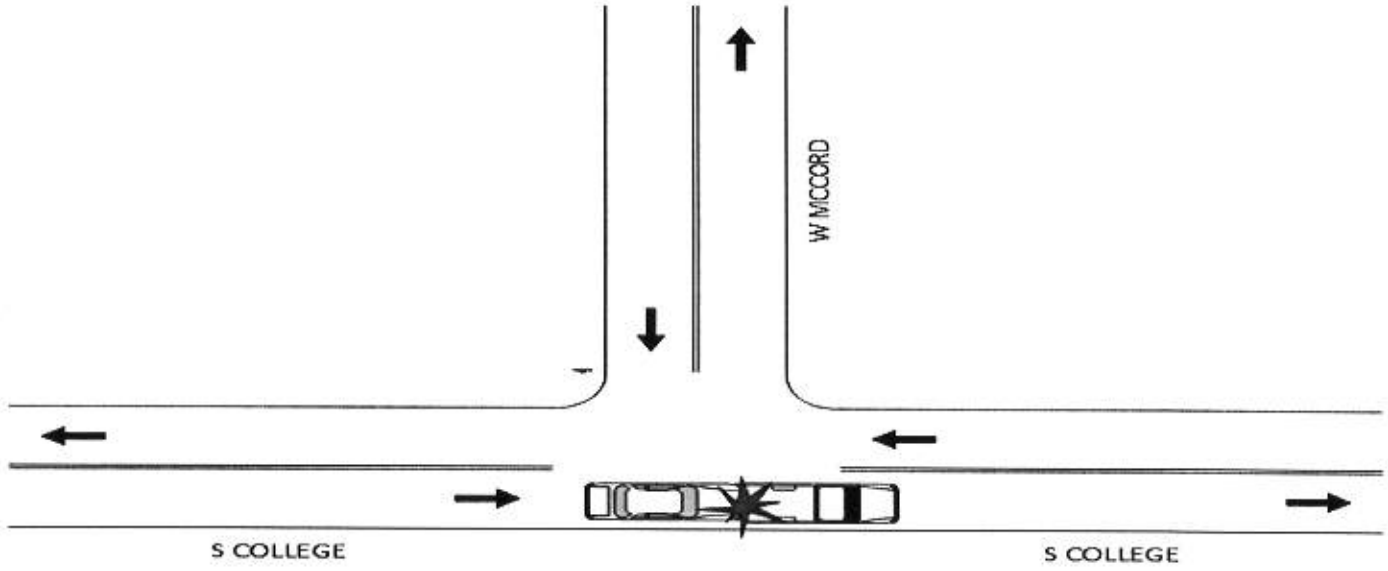

On 03-01-2019 at approximately 0914 hours, Officers responded to the intersection of South College and West McCord for a report of a traffic crash.

Upon my arrival, I noticed a Nissan Altima with minor front end damage and a Chevrolet 2500 with minor damage to the rear end. The drivers had pulled forward slightly and to the side of the road. I asked both drivers to pull into a nearby parking lot for the safety of everyone involved.

I made contact with the driver of the Nissan and she was identified by her Missouri Driver's License as Sharon Tamol. She stated she was stopped in traffic and believed her foot slipped off the brake pedal. She said that was when her vehicle collided with the vehicle in front of her.

I made contact with the driver of the Chevrolet and identified the driver as Barry Ruddick by his Missouri Driver's License. Mr. Ruddick stated he was stopped in traffic, waiting on a tractor trailer to turn from the stop sign at the next intersection. He stated the vehicle behind him struck him from the rear.

Both parties stated they were uninjured when I arrived on scene. Neither vehicle required towing due to damage.

At the conclusion of my investigation, after speaking with both drivers, I determined the driver of the Nissan provided the probable contributing circumstance of following too closely by not leaving enough room to safely stop, resulting in a traffic crash.

I have nothing further to add at this time.
